### PRESIDENT'S MESSAGE



Dear Friends,

Sacramento Unit 505 does not have an "open" club large enough to house over 22 tables. The Board has discussed having multiple sites for Unit Games from time to time.

On April 18, 2010, the Board passed a motion that, "The Unit hold games at multiple sites starting June 27, 2010, on the same day and time, for a playing fee of \$8.00 per person, with \$1.00 being paid to Unit 505, and the balance going to the club for fees and hospitality. Barbara Vann will provide hand records and Director's strats for the Unit game."

There is no Unit game scheduled for May and the next game is not until June 27th, so it gives you and the clubs time to discuss and plan ahead. Each club would be responsible for their fees and hospitality functions.

Bridge players could attend any Unit Game site. Reservations could be required. We usually have a few people who come at the last minute. A phone call on the day of the game (common courtesy) would let players know if there is still room available at the club they want to attend. If the club is planning lunch before the game, it makes a lot of sense to know whether to prepare enough for 15 tables or 20 tables, a difference of 20 people.
